8	Most of the report rests on the premise that state sector productivity is poor and slowly growing. The report provides weak evidence of this from Stats NZ's productivity series. However, this is primarily driven by the education measure of productivity, and I think is not adjusted for quality changes. A more nuanced analysis could have looked at private vs public schools or hospitals, or comparisons with public sectors overseas. The Report also had an excessive focus on the Budget process. The Budget is a political process - it is about politicians deciding what they want to 'buy' for NZers. It is important that advice from departments are high-quality and evidence base, but we must be realistic that final decisions are made by politicians on political criteria. For example, the 2018 Budget was purely focussed on manifesto commitments and coalition agreements. Finally, the Report only weakly tackles criticisms of measuring productivity, such as perverse incentives, distraction from outcomes focus. The Report has a good recommendation on using productivity measures for accountability. But it provides no example of productivity measures that would satisfy that recommendations criteria. In many sectors there may not be one, or it may be that outcome measures are better at meeting those criteria than productivity measures. The comment that productivity measures should be part of balanced accountability frameworks is a good one. However, accountability frameworks have to do a lot of different things already. It is not clear, and the report does not analyse whether, using productivity measures overcomes the opportunity cost of not measuring something else, or having a more focussed framework. Also, no evidence was put forward that agencies / entities are excessively focussed on outcomes, and shifting to a balance between outcomes and outputs would improve the situation.	8/20/2018 11:59 AM
