RMBA welcomes and supports the inquiry being untaken by the Productivity Commission into the use of land for housing.

Recently RMBA and the Construction Strategy Group commissioned research from the Building Research Association of New Zealand into the impact of regulation on housing affordability.

The final report was received by us a couple of weeks ago and is currently being circulated to the RMBA Board. There are a number of aspects within this research that relate to the land aspects which are relevant to your inquiry.

Whilst the whole report may be of interest and benefit to your inquiry, the following sections are considered most relevant:

- Specify and limit authority of planners and free up market
- Be more diligent in complying with District Plan requirements
- Standardise conditions that trigger a resource consent
- Bulk up large-scale earthworks and infrastructure changes
- Improve and audit DC allocation of new macro-infrastructure benefits
- Smooth DCs by applying a rolling average cost
- Institute more inclusionary zoning and limit BCA and restrictive covenants
- Incentivise more rapid development of appropriately zoned land
